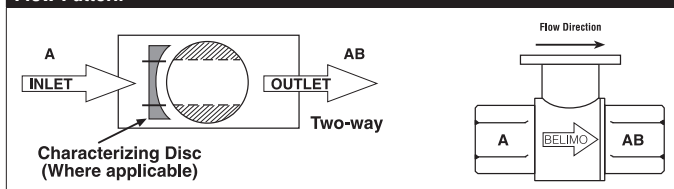

Flow Pattern



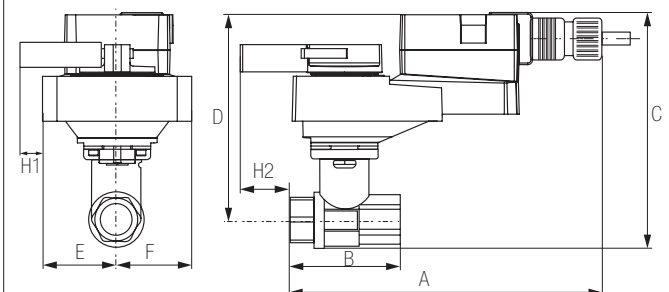
Application

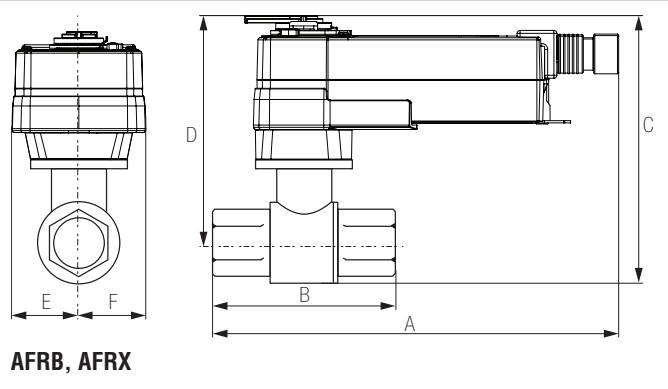
