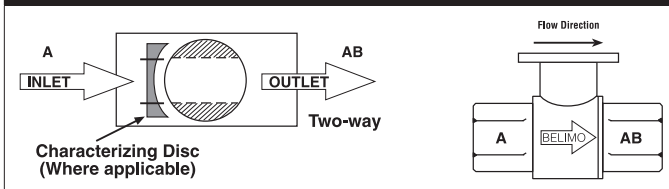

Flow Pattern



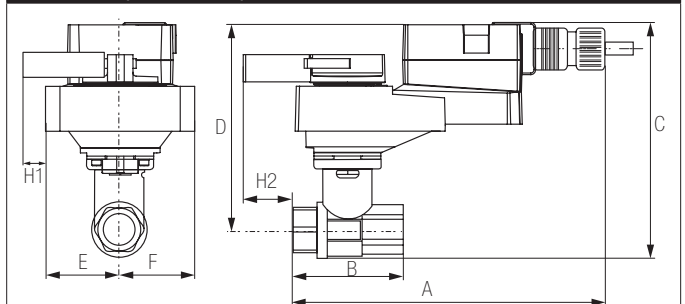
Application

✂️ INSTALLATION NOTES

- 1 Provide overload protection and disconnect as required.
- 2 Actuators may be connected in parallel. Power consumption and input impedance must be observed.
- 3 Actuators may also be powered by 24 VDC.
- 5 Only connect common to negative (-) leg of control circuits.
- 7 A 500 Ω resistor (ZG-R01) converts the 4 to 20 mA control signal to 2 to 10 VDC.
- 12 IN4004 or IN4007 diode. (IN4007 supplied, Belimo part number 40155).
- 18 Actuators with plenum cable do not have numbers; use color codes instead.
- Meets cULus requirements without the need of an electrical ground connection.
